- 5) All vehicles must be in designated parking spaces by 8:00 AM daily & may not be operated inside the fence during fair hours.
- 6) All exhibits must be removed from the grounds by Monday, July 30, 2018.
- 7) All exhibits will be left at the exhibitors' own risk.
